Any deliberation of the issue is limited to a proposal to place it on the agenda for a later meeting.

5. Consent Agenda.

All Consent Agenda items listed are considered to be routine by the City Council and will be enacted by one motion. There will be no separate discussion of these items unless a Council member requests in which event the item will be removed from the Consent Agenda and considered in its normal sequence on the agenda. Information concerning consent agenda items is available for public view.

- A. Consider approval of minutes of the Special Meeting conducted on February 16, 2013 and Regular meeting conducted on February 12th and 26th, 2013.
- B. Consider Proclamation encouraging support of Lemonade Day on Sunday, May 5, 2013.
- 6. Action on a Final Plat and exception requests from Section 30.03.004(b) [Minimum Block Length] and Section 30.03.003(e) [Dedicate Easements by Separate Instrument] for Bella Colinas Section 1, a part of the "Masonwood Development," located on the Grumbles tract in the Bee Cave Extraterritorial Jurisdiction on the south side of 71,

approximately 1.6 miles west of Hamilton Pool Road including approval of fiscal security and improvement agreement.

- 7. Discuss and consider an update regarding a shade structure around the small pavilion at the Bee Cave Central Park.
- 8. Discuss and consider an update regarding the relocation of the dog park at the Bee Cave Central Park.
- 9. Discuss and consider action on the appointment of a member to the Planning and Zoning Commission, Position 6 and the appointment of a Vice Chair.
- 10. Discuss and consider authorizing the City Administrator to sign a contract with CAPCOG for the purchase and implementation of My Permit Now software for plan review and inspection status for the Community Services Department.
